

Rental Agreement

A security deposit of 25% of the Rental Fee is required to secure the date requested. The deposit is in addition to the Rental Fee to ensure proper cleanup. The deposit is non-refundable if the reservation is cancelled.

AGREEMENTS:

The renter agrees to abide by and enforce the following rules of personal conduct and behavior for the clubhouse and grounds:

1. Persons entering or leaving the grounds shall drive in a safe and cautious manner at all times. No person who has consumed alcoholic beverages shall drive a vehicle on the club grounds.
2. The use of the club shooting ranges is not included in this rental agreement and use of firearms is **STRICTLY PROHIBITED**.
3. No hunting or camping is allowed on club property. Campfires not allowed except in the designated area.
4. The rental period is from 10 am on the scheduled rental date until 10 am on the following day, unless an adjusted rental time is agreed to between the club's rental chairman and the renter.
5. The renter **must be at least 21 years of age**, and must be present at all times during the rental period when the facility is in use.
6. Use of alcoholic beverages must be in compliance with all New York State Liquor Laws and **no person under 21 years of age** may consume alcoholic beverages on the club grounds.
7. The renter agrees to reimburse the Wellsville Rod & Gun Club in full for any costs associated with repairs for any and all damages to the club facilities as the result of actions or negligence by any person(s) in attendance during the rental period.
8. The renter shall be responsible for adherence to these provisions and for the conduct of all guests.

CLEAN-UP AGREEMENT

1. All trash/garbage including bottles and cans are to be removed from the club facilities by the end of the rental period.
2. Floors must be swept and/or mopped as necessary.
3. Kitchen, stoves, sinks, cupboards and counters must be left clean and orderly.
4. If the BBQ pit is used, it must be cleaned accordingly.
5. Lights, water and stoves, etc. must be shut off before the clubhouse is closed and locked.
6. Wood stoves must be left in a safe manner.
7. It is the responsibility of the renter to supply the necessary items for proper clean-up.

Inspection of the facilities will be conducted following the rental period to assess clean-up and identify any damages. The renter's deposit will be refunded within 15 days upon satisfactory inspection.
